The Auditor

The audit profession is at a tipping point. Without significant innovation in its business model, staff recruitment strategies and audit execution processes, the audit profession may not remain relevant in the 21st century. As Charlton Heston put it: 'There's a temptingly simple definition of the epic film: it's the easiest kind of picture to make badly.' This book goes beyond that definition to show how the film epic has taken up one of the most ancient art-forms and propelled it into the modern world, covered in twentieth-century ambitions, anxieties, hopes and fantasies. This survey of historical epic films dealing with periods up to the end of the Dark Ages looks at epic form and discusses the films by historical period, showing how the cinema reworks history for the changing needs of its audience, much as the ancient mythographers did. The form's main aim has always been to entertain, and Derek Elley reminds us of the glee with which many epic films have worn their label, and of the sheer fun of the genre. He shows the many levels on which these films can work, from the most popular to the specialist, each providing a considerable source of enjoyment. For instance, spectacle, the genre's most characteristic trademark, is merely the cinema's own transformation of the literary epic's taste for the grandiose. Dramatically it can serve many purposes: as a resolution of personal tensions (the chariot race in *Ben-Hur*), of monotheism vs idolatry (*Solomon and Sheba*), or of the triumph of a religious code (*The Ten Commandments*). Although to many people Epic equals Hollywood, throughout the book Elley stresses debt to the Italian epics, which often explored areas of history with which Hollywood could never have found sympathy. Quo Vadis?

This book focuses on the discovery of a common genetic basis for a group of inherited neurological disorders, including Huntington's Disease, spino-bulbar atrophy and a series of hereditary ataxias. This shared molecular background and other similarities have led to the development of theoretical models for the pathogenesis of these diseases. It is now also clear that the mechanisms involved are likely to be of more general relevance, outside of this particular group of disorders, with implications for other neurodegenerative processes such as those involved in Alzheimer's, Parkinson's and Prion diseases. The book is an edited and updated compilation evolving from a Royal Society discussion meeting.

The Epic Film

A Question of Honor is the gripping, little-known story of the refugee Polish pilots who joined the RAF and played an essential role in saving Britain from the Nazis, only to be betrayed by the Allies after the war. After Poland fell to the Nazis, thousands of Polish pilots, soldiers, and sailors escaped to England. Devoted to liberating their homeland, some would form the RAF's 303 squadron, known as the Kosciuszko Squadron, after the elite unit in which many had flown back home. During the Battle of Britain, they downed more German aircraft than any other squadron, but in a stunning twist at the war's end, the Allies rewarded their valor by abandoning Poland to Joseph Stalin. A Question of Honor

Catholic Literature and Film: Incarnational Love and Suffering is meant to be considered as a work of literary criticism, not film adaptation studies. In it, the author explores six literary works dealing with Catholic themes and the film versions of these works. The discussion of the films is at the service of analyzing the texts. Underlying all the discussions is an incarnational, sacramental view of the texts, which links to my interpretation of the film versions of them. Catholic and actually any Christian interpretation of literature or film or any other art form is rooted in an iconic and sacramental understanding of imagery as a means of conveying the sacred. Catholic spirituality lends itself to this sort of approach, as it is deeply rooted in the ability to see sacred things through physical means. A key sub-theme is romantic love in connection with salvation, which Charles Williams, one of the "Inklings" (the group of British writers, including J.R. R.

Tolkien and C. S. Lewis, who met and discussed literature and theology), calls “the theology of romantic love,” as well as the sub-themes of redemptive suffering, and grace. My interest in the book is not an analysis of cinematography, per se, but on the films as vehicles for religious ideas. What makes this approach unique is that it doesn’t deal with only faith and film, as Peter Frazer does very well in his book *Images of the Passion: The Sacramental Mode in Film*, for example; it also goes beyond the realm of strict literary criticism in its tackling of how religiously oriented works of literature are affected by the transformation into film.

City of Light joins the recent reissues of four of Cyrus Colter's books by TriQuarterly Books/Northwestern University Press. Colter concludes his grand literary project with a work that is foremost a novel of ideas. Though City of Light may appear realistic in setting (contemporary Paris), with a well-differentiated cast of believable moment, each character nonetheless represents an idea or a position regarding the issue of race in American life. The ideas or positions range from black nationalism, drawing upon African models and an Afrocentric political position, to complete assimilation, presented here by the central character's love affair with a white woman. Paul Kessey, at age twenty-nine, is caught between two worlds. Although his is a privileged world of successful blacks in Chicago, and he is a graduate of Princeton, handsome and well-connected, Kessey is uncertain how to identify himself in relation to the African diaspora, partly because of his own light skin. Throughout his Parisian sojourn, he is both attracted and repelled by different ideas, attitudes, and concepts regarding the place of blacks in a white society; he goes back and forth among the persons -- and the ideas they represent -- and thus among contradictory possibilities of life as a black man. By intertwining in an intricate web racial, class, and political issues with the intense struggles of one man's heart, Colter presents a vivid portrait of the personal effects of prejudice and its hypocrisies. City of Light remains a daring push against the grain of American literary fashion, both in its method and in treating interracial relationships, Afrocentrism, and the black middle class.

I Challenge the Education Culture!

Conceived by General Sir Robert Baden-Powell as a way to reduce class tensions in Edwardian Britain, scouting evolved into an international youth movement. It offered a vision of romantic outdoor life as a cure for disruption caused by industrialization and urbanization. Scouting's global spread was due to its success in attaching itself to institutions of authority. As a result, scouting has become embroiled in controversies in the civil rights struggle in the American South, in nationalist resistance movements in India, and in the contemporary American debate over gay rights. In *Race, Resistance, and the Boy Scout Movement in British Colonial Africa*, Timothy Parsons uses scouting as an analytical tool to explore the tensions in colonial society. Introduced by British officials to strengthen their rule, the movement targeted the students, juvenile delinquents, and urban migrants who threatened the social stability of the regime. Yet Africans themselves used scouting to claim the rights of full imperial citizenship. They invoked the Fourth Scout Law, which declared that a scout was a brother to every other scout, to challenge racial discrimination. Parsons shows that African scouting was both an instrument of colonial authority and a subversive challenge to the legitimacy of the British Empire. His study of African scouting demonstrates the implications and far-reaching consequences of colonial authority in all its guises.

The Rotarian

George Kleine was a New York City optician who moved to Chicago in 1893 to set up an optical store. In 1896 he branched out and began selling motion picture equipment and films. Within a few years he became America's largest film distributor and a pivotal figure in the movie business. In chronicling the career of this motion picture pioneer -- including his rapid rise to fame and fortune, but also his gradual downfall after 1915 as the era of Hollywood began -- Joel Frykholm provides an in-depth account of the emergence of the motion picture business in the United States and its development throughout the silent era. The Routledge World Companion to Polish Literature

Polish contemporary literature is not a closed book to European and world readers. Those not involved professionally in the production or study of literature may well have heard of Stanisław Lem, Witold Gombrowicz, Czesław Miłosz, Wisława Szymborska or the recipient of the Nobel Prize in Literature for 2018, Olga Tokarczuk. The situation is different with Polish literature of earlier periods, including the eighteenth- and nineteenth-century novel. The works of Ignacy Krasicki, Michał Czajkowski, Józef Ignacy Kraszewski, Eliza Orzeszkowa, Maria Komornicka, Stefan Żeromski and Bolesław Prus - the exception perhaps is Henryk Sienkiewicz, whose novels were translated into many languages - did not enter European circulation on any large scale and have rarely been included in comparative studies. Our book attempts to change this perspective and poses the question as to whether another - expanded and more inclusive - literary canon is possible. This book assesses the impact of energy transitions on the future of natural gas in the EU energy mix. As we approach 2050, the requirement to sharply decrease CO₂ and other GHG emissions means that the role of gas infrastructure in the EU and beyond will change drastically. But what does such change mean? To address this question the author critically analyses the EU's evolving natural gas market policy and law. Clearly structured throughout, the book explores the following questions: How can we maximise the potential of gas infrastructure to reduce carbon emissions? What are the lessons learned from decision making experience in the natural gas sector? Is the EU moving towards or away from a climate neutral gas sector? How will green and low carbon gas technologies be supported? And, are proposals to drive a growing share of hydrogen, biomethane, and synthetic methane to the system just an excuse to prolong fossil fuel operations? The book explores whether the EU will continue to subsidise natural gas projects or decarbonise the gas grid before 2050, and at what cost. Recommendations are proposed for a new regulatory and policy framework for development and operation of hydrogen pipelines, injection of biomethane into the existing gas grid and for pipelines carrying CO₂. Filling an important gap in the literature, this book aims to develop an understanding of and clarify the complex range of legislation involved within a single analytical framework. Although the focus is mainly on the future of gas in the EU, the findings and recommendations are relevant for a much wider geography. This book will be an invaluable reference to policy makers and practitioners as well as researchers and students across the social sciences interested in the future of energy.
